These shows are meant to be a low key, pleasant showing experience for the green horse and/or novice rider. We welcome gaited Dressage, Western Dressage, Quadrilles, Freestyles, Drill Teams and other Exhibitionists. If you want it judged or you just want to show off or practice-- FRC wants you at our shows!

We will also have schooling for stadium jumping for the shows. The tentative schedule is as follows (check website for actual times):

10:30-11:00 Intro (up to 1')

11:15-12:00 Hopeful (up to 2')

12:15-1:15 Beg. Novice (2'6")

1:30-2:30 Novice (2'11")

2:45-3:15 Training (to 3'3")

Schooling trips are \$5 per round — pay as you go on day of show.

Closing Date: In hand 1 week prior to show date. Late fee is \$10 if accepted.

Stuff to know:

- Any horse on the grounds must check in at the show office with a current Negative Coggins and obtain a number (even if just walking on the grounds).
- All riders must wear protective head gear while mounted with harness securely fastened (includes upper level rides)
- USEF and USEA rules generally apply, to anyone who knows the difference!
- Coats are not required, braiding is not required.
- Boots are not required but appropriate footwear with heels is.
- No refunds after closing date unless your slot can be filled.
- Dogs must be leashed at all times.
- Ribbons for 1st through 6th place in each class. Classes may be combined in case of insufficient entries.
- Make checks payable to FRC. Mail with a current Coggins to Show Secretary by closing date. If your Coggins is on file with the show secretary check "Coggins on file" on your entry.
- Start time is 8:00 am.
- Put special requests on your entry form -- we will try to accommodate all we can but we need to know **BEFORE** we set the schedule.

Show times will be posted on www.foothillsridingclub.org by Wednesday before the show or you may call 828-863-4924 to get your time. If you **CLEARLY** print your e-mail address your ride time will be e-mailed to you (I am old and can't read small or squiggly printing!)

SCHOOLING:

As of the printing of this flyer there has not been a decision at two of the venues about riding on the grounds the afternoon before the show. When you get your ride times you will get the information about schooling at that venue. Check the FRC website for updates.

Coggins:

We will keep a record of your Coggins on file for all FRC shows so you do not have to send in a Coggins each time unless yours has expired. Check the FRC website for the latest listing.

Difference in fees at each venue... what is that all about?

Each facility charges us for us of their grounds and we help pay for this through the fees we charge. FENCE has raised FRC fees by 25% so we need to cover that cost.

We strive to put on affordable shows but we must still pay for the shows from the show proceeds and pay for the show supplies and expenses of the club from the show income. We are forced to raise our prices to meet the increased costs at FENCE. Please do not complain to us about this increase—express your concerns to FENCE! 828-859-9021

So, bottom line, it will cost more to show at FENCE than at Harmon Field or Riverbend.
